TRANSACTION PROCESS

Five stages. Clear responsibilities.

01	Define	Clarify the buyer or project, product specifications, quantity, timing, origin, destination and proposed cooperation model.
02	Source & Review	Approach suitable manufacturers or suppliers, request pricing and review information required to assess the parties and opportunity.
03	Structure	Align responsibilities, specifications, commercial terms, payment procedures, contracts and required documents.
04	Coordinate	Maintain an accountable communication flow and coordinate product, trade and transport documentation through the delivery cycle.
05	Follow Through	Track agreed milestones, resolve open documentation points and support an orderly transaction close.

The exact scope of Seven Heavens' role is defined separately for each transaction.

Any new or changed payment instruction should be independently verified through a previously known official contact.

05**Trade documentation**

Relevant product, origin, quality, commodity, shipping and transport documents are coordinated according to the transaction.

06**Ethical conduct**

We expect accurate information, genuine documents, lawful conduct and professional dealing. Bribery, fraud and falsification are not acceptable.
